Teams of 2 (or 3 if desired) riders, any age, taking the course at a safe and sensible "hunting pace". The course will be well marked; about 8-10 miles long, and contain 35-40 fences. There will be a mandatory rest stop of 3 minutes on the course. First ride out at 9:00a.m.

- JUMPING DIVISION  
Jump all the fences.
- HILLTOP DIVISION (PICK & CHOOSE)  
Jumping fences optional, there is a way around all the fences.
- JUNIORS  
A hilltop division for teams with a rider 18 and under.
- SENIOR HILLTOP  
A HILLTOP DIVISION FOR OUR TEAMS WITH A RIDERS 55 AND OVER.

ENTRY FEE - \$45 per rider pre-entry, \$50 post entry fee.

ATTIRE - ASTM/SEI Certified Helmets mandatory, any safe attire acceptable.

RIBBONS - Ribbons through tenth place.
